It is a world of people who, through no fault of their own, were born into this world with a disability. These people are in a situation that they cannot influence or change, which nevertheless limits them and in many ways prevents them from living their lives the way other people do. The expectations that these people have reflect their desire to live a full life. They also want to be useful for their environment. I would like to express my opinion that in this context, questions of considerable importance remain open in our society. The essence of these issues lies in the relationship between people who externally meet the criteria of excellence and people with disabilities. In their mutual understanding, expectations and possibilities of mutual help. Such interplay can only occur if they know each other. There is often an abyss between the world of people with disabilities and the world of people who do not have them, or even as if it were a wild river that prevents both of them from crossing the other bank. Is it possible to build a bridge so that these two worlds can meet? I would like some of the ideas from this book to contribute to this.</p>
